

IMZA 'AUCTION PURCHASED CATTLE' TRANSFER AUTHORIZATION

IMPORTANT: This is not a transfer form. This document should accompany a transfer form when registering cattle purchased at auctions. It is never to be used for any type of private party sale. If you are a private party buyer and a seller gives you this form - reject it. The IMZA only allows the seller to submit requests for transfer, never the buyer (with the exception of auctions). If this form is submitted to the IMZA for anything other than a legitimately documented auction purchase, it will be rejected. This form expires 6 months after the auction date.

This form is to be completed by both the buyer and the seller. In accordance with the IMZA bylaws and policies, only the documented owner (listed on the IMZA registration certificate) of an IMZA registered animal may initiate a transfer of ownership of that animal to another person. This form acts as an authorization by the owner/seller of an IMZA registered miniature zebu for the buyer to complete the transfer of ownership of the specified animal from the seller/owner's name into the buyer's name on his/her behalf. This document is only valid for 6 months from the date of the auction where the sale takes place. This document is valid for one animal only; if multiple animals are being sold each animal will need it's own individual form completed. The original copy of this form, completed in its entirety and signed by both parties, must be submitted to the IMZA registrar along with a separate transfer request document and payment for transfer. Additionally, the original dated copy of the official purchase receipt or sale record provided by the auction must also be submitted with the application (dates on auction slip must match date of sale listed by the owner/seller on this form).

NOTE TO OWNER/SELLER: By signing this document, you are confirming that you are the legal owner of the listed animal and that you are the person who's name is listed as the owner on the official IMZA registration paperwork. You are giving legal authority to another person to transfer documented ownership of the specified animal out of your name and into theirs. You authorize the IMZA to transfer documented ownership out of your name and agree to hold the IMZA harmless for any future claims or disputes of ownership.

NOTE TO BUYER: Be sure you receive both this form (completed & signed) AND an official IMZA registration document from the seller. If the seller only provides you an application for the animal to be registered, the IMZA will not register or transfer the animal to you (registrations can only be completed by the dam's owner at time of birth). If you fail to promptly submit this completed form & supporting documents to transfer the specified animal into your name, the specified animal will not be recognized as being owned by you, but will rather maintain its documented owner as another party. We encourage you to submit this form & supporting documents promptly and remember that it expires 1 calendar year after the specified auction date. After 6 months, only the previous owner will be able to transfer the animal into your name.
